A word from the Chairman

Hello Dorset Ramblers and a Happy New Year to all. I hope that you've managed to do some walking despite the very wet weather.

I'm sorry that more of you didn't make it to the Area AGM in Broadmayne last November. We had a good discussion about the proposed governance changes, a talk about the Wessex Wanderer Railway Walks from one of its founder members, Sylvia Popham, (see here for further details [Wessex Wanderer Railway Walks](#)), and an excellent lunch. The Wessex Wanderers are a Ramblers flexi-group hosted by Dorset Area. Please do consider joining one of their walks on the Weymouth to Bristol line in the coming season. This is a great way of seeing new parts of Dorset and our neighbouring counties. We also managed to fit in a quiz and a raffle.

The governance review which is being undertaken by the Ramblers Board of Trustees has still to reach a conclusion. Area Council has been participating in the process by submitting comments over the course of the last year and the consultation process culminated in a General Council conference meeting last December which was attended by our General Council delegates. The main subjects debated at the conference were a new trustee election process (one member, one vote) and the replacement of General Council with regional forums which will be open to all members. As a result of what was said at the conference, it's the Boards intention to share updated proposals for further consultation, along with drafts of the Articles of Association and Standing Orders before the General Council papers are published. The final proposals will be presented to General Council for decision on 25 April 2026. Following General Council, the Board has committed to set up a separate project, building on responses to date, to look at the operating model for Areas and Groups.

You may be wondering what has happened to the Dorset Area 50th anniversary favourite walks project. As you know, we invited Groups and individual members to submit outlines of their favourite walks for this project. The intention was to then pick 50 from those submitted and ask the authors of those chosen to expand on them for publication on the Area website. Sadly, we didn't receive 50 suggestions, but our webmaster and I agreed that it would still be a good idea to start to publish some walks on our website. Everyone who had contributed a walk or walks has therefore been invited to present their walks in a specified format if they would like to see them published. We see this walks library as something which will build up gradually over time. Look out on the website for the first walks to appear and if you would like to contribute a walk, please do let me know.

Pulham FP20: From GR ST 731 077 to ST 725 075, from 19.01.26, for 26 weeks, to allow construction of solar farm. Alt route.

Sturminster Newton FP2: From GR ST 78633 14446 to ST 78952 14499, from 03.12.25 for 26 weeks. To allow development. Long alt route.

Winfirth Newburgh BR17: From GR SY 80225 86404 to SY 80247 85226 from 05.01.26 for 26 weeks. To allow trenching and cabling works for a solar farm. Anticipated completion 30.01.26. No alternative.
